THE COLLISON'S OF PIRTON, HERTFORDSHIRE

INTRODUCTION

I have been researching our family history for many years and recently opted to collate everything I had with snippets of history and put it into books for my family. One of our ancestors being William Wilmer Collison baptised in Pirton, Hertfordshire in 1737 his parents being "Robert Collison" and "Dorothy Underwood", I then found a "William Collyngson" who died in 1602 but finding if or how our ancestry connected was a surprisingly revealing and interesting venture and only possible thanks to the research, surveys and transcriptions by Helen Hofton and the Pirton Local History Group.

The history of Pirton has been very well researched, nearly every document relating to the village and its inhabitants has been transcribed, the old houses surveyed and many archaeological digs have taken place. The Manor Court Rolls of the 1300's contains the surnames Sam, Smyth and Caleson - all names relevant to our ancestry [the Court Rolls also names Communal Ale tasters!]. In the early 1500's some of its land and properties was sold to Eton College - again relevant to the Collison history.

Of course, the research wasn't straight forward, as per tradition of the time, William had a son, three grandsons and many descendants named "Robert" and like every family historian finds - there are vital records missing, however through Wills, Manor Court Rolls, surviving parish records, Hertfordshire Archives and the National Archives, I have been able piece the family together, visualise how and where our ancestors lived - Yeoman, initially living in a two storey cottage with 28 acres of land rented or retained from Eton College, some strips of land, a few animals and pewter tableware; gradually, their wealth grew over the generations, they had grander houses built, extensions to properties, swords and daggers, by the mid to late 1600's, they were farmers / gentlemen with "Drinking houses", china and silverware bearing their own mark and hearths to pay tax on.

So back to William Collyngson, on the next page you will see the family tree and the following pages - evidence gathered for each male descendant and how properties were passed down through the generations.

• William and Elizabeth's date of birth and marriage is an estimate based on his son Robert being about 21 years old when he married in 1685. Eldest children were traditionally named after their father, therefore it is unlikely Robert was their eldest son but the only surviving son at the time of William and Elizabeth's decease

- Elizabeth Smyth I believe her maiden name was Smyth, as she names her James Smythe as her kinsman in her Last Will and Testament. [Ref:2]
- William and Elizabeth were born before the dissolution of the Monasteries when many records were destroyed, if they were made in the first place.

SUMMARY: William and Elizabeth appear to have old family links in Pirton as there are 14TH Century Court Rolls which document the names "Caleson" and "Smyth" [Ref: 3]. Their date of marriage and how many children they had remains unknown but evidence from their Last Will and Testaments name their son Robert [1][born c. 1565] and his 4 children - Robert, William, Elizabeth and Bennit, plus daughter Elizabeth who married Christopher Farmer [buried 29th May 1600]. [Ref: 1 & 2]

William was a Yeoman which meant he was of an "intermediate" class - neither gentry nor a labourer, usually a land owner or a "retainer" which also meant he was not being required to bear arms. [Ref: 4] His Will records he owned some land [or strips of land] and the family also rented / retained land owned by Eton College [a possible collaboration with the local "Hammond Family" [Ref: 1]

The family were not listed among the wealthy land owners of the village but William would have employed some labourers to help him on the land. Prior to 1586 William, Elizabeth and his family lived at Elmtree Farm. In 1586 and 1596 William is named in the Pirton Manor Court Rolls of Elmtree Farm as owner of Crabbes Cottage with 6 acres of land and 28 acres of land which I believe was Elmtree Farm. [Ref: 6], According to building surveys Elmtree Farm was a 2 storey cottage consisting of one room on each floor with a ladder as access to the upstairs and had a large fireplace on the ground floor, Crabbes cottage was a single storey cottage consisting of one room and a hearth with possible similarities to the image right.



I believe the "ownership" was a lease from Eton College for a period of twenty-one years and a payment of £10 2shillings plus a portion of the crops grown and a sheep or a pig, a person could lease up to the value of £20 for land / property per year [Over £1740 today]

Note: In 1516 Eton College was granted much of Pirton, Ikylford, Offley and Ramerwick, which included 20 properties, 14 tofts [cottagers yards], 600 acres of arable land, 200 acres of meadow, 200 acres of pasture, 100 acres of wood and 300 acres of heath. [Ref: 3]

Like many families of the time they owned a few animals, pigs, sheep and cows for their food, William also had an Orchard, Malt House and grew Barley indicating that he brewed his own mead or ale. [Ref: 1] It was customary at the time for parents to gift property / land or money to their sons and daughters at the time of marriage or coming of age; his son Robert married in 1585 and in 1586 William and Elizabeth are recorded in the Pirton Manor Court Rolls "holding messuage*: Crabs and 28 acres"; suggesting William and his wife Elizabeth moved from Elmtree Farm to Crabbes for his son to take over the farm.

Messuage - a dwelling house with outbuildings and some land assigned to its use

Towards the end of William's life, he surrendered some of his land in Ballands to Thomas Dowcra [A large local land owner] in 1596. Animals weren't included in his inventory which suggested William gifted the animals to his family prior to his death. William had his Last Will and Testament written in 1601. [Ref: 14]

Elizabeth [daughter of Robert] 1 ewe to be received 1 month after decease 1 quarters of Barley to be delivered 1 year of decease

His wife Elizabeth 2 Acres of the best Wheat and 7 acres of Barley yearly during her life, to pay Robert to keep it and bring it home and place in the mault house, 2 kyne [cows] and 2 hoggs yearly and to choose when they are fat enough, And to be provided with 20 shillings of fire wood yearly, To have the benefit of the Orchard, The grain in the barn should be sold to pay rents and reparations, if any left my wife to have half. William bequeathed 4d to every household of the poor. His Last will and Testament was likely written by the village Priest or Cleric.

The Will is incomplete

William's wife Elizabeth continued to live at Crabbes Cottage another eight years, she wrote her Last Will and Testament on the 13th August 1610. Elizabeth's Inventory describes her living in a one roomed house and owned four acres of land, valued at £6 6 shillings and 8 pence, animals were worth £2 3 shillings and 4 pence which consisted of two cows, Elizabeth was owed £28; her clothing was valued at £3 6 shillings and 8 pence and she had £1 of ready money in her house, her household goods were valued at £8 3 shillings plus grain and barley. [Ref: 2 & 14]

- St Mary's Church, Pirton was an early 11th Century Cruciform Church with rebuilding over the years, the layout changed in 1839 [Ref: 9]
- William and Elizabeth saw a huge change to England during their lifetime, the closure of the monasteries, Henry VIII died in 1547, with Edward VI, the book of Common Prayer in 1547 was introduced, Over 300 Protestants were burnt at the stake, Mary Queen of Scots beheaded, the Armada, William Shakespeare [1564 1616]. A poor law introduced in 1601 where people had to support the poor, taxation was high, the church had much of its wealth taken away and in 1603 Elizabeth I died and James I came to the throne, and in 1605 there was the Gunpowder Plot. There was a lot of tension in England and village disagreements were dealt with Quarter sessions one of Pirtons village revolts had to be sorted out by the London Courts, none of the Collison family were involved.
- The Poor Law 1601 Prior to 1601, if you were poor it was considered your own fault but with the fear of rebellion, crime, fear the poor may spread disease in the late 1500's vagabonds could be whipped or hanged. The Poor Law imposed a nationwide tax where everyone had to contribute. Begging was banned and if caught, sent back to their place of birth which would provide for them [by standing before the local community leaders and asking for a shirt or food]. Alms houses were established for the genuine poor to live in.

"I give x shillings to the children of Elizabeth Farmer late wife of Christopher Farmer deceased The unbequeathed to pay for my funeral expenses and the rest to her son Robert her sole executor".

• Agnes Ancel / Ansell was the daughter of Richard and Martha Auncell [both buried in 1600] Pirton [Ref: 3], she had many siblings. The Auncell's / Ansells [many different spellings] were a big family in Pirton and there is a huge amount of information on the Pirton website relating to the family, they had a hand in everything, Church Wardens, Jurors, land owners, tenements and the village pub. There is a record of baptism for an "Agnes Auncell" baptised on the 15th December 1584, twelve months before the marriage of our Agnes, her parents weren't documented [it raises the question - could they have been ex-catholic?]

SUMMARY: Robert and Agnes were married on the 10th November 1585 at the church of St Mary in Pirton, they had three sons named Robert [1586], William [1588] and Bennet [also spelt Bennit] [1600] and a daughter named Elizabeth [1589].

The family lived in Pirton like generations before them and like his father, Robert was a Yeoman, he owned some freehold land and rented / retained additional land. In 1586 Robert's parents William and Elizabeth lived at Crabbes Cottage and leased Elmtree Farm where Robert and Agnes lived after their marriage, they owned a few animals, an orchard, grew wheat and barley and owned a Malt house, indicating that the family brewed ale, beer or mead [the favoured drink of the time]

In 1588 there was a village revolt where some of the villagers rose up against the local landlords, most disputes were dealt with at a local level however the Pirton revolt was taken to the "Court of Star Chamber" held at the palace of Westminster by the Privy Council [Elizabeth I was on the throne]. Robert Copcote and William Hammond [local Gentry / land-owners] bought charges against Robert Auncell, John Sex and Thomas Hanscombe, the men were found not guilty; but at a Quarter Session later the same year, Thomas Auncell bought charges against Robert Copcote and William Hammond – stating their initial charges were revenge following an incident where weapons were drawn following insults instigated by Robert Copcote's wife – who had been accused of adultery by the church wardens [the Ancell's were both Church Wardens and Juror's] resulting in Robert Auncell's wife spending a night detained at the local parsonage. The local gentry were also accused of abusing their power with regards to rights of the common land and the effect on the poor of the village. The Auncells had enough and were fighting back – but the common man had little say back then, the dispute went on for months which must have caused tension within the village. The Collison's were not mentioned in the dispute; the Auncell's were Agnes's brothers. [Ref: 10]

In 1600 Agnes's mother [Martha Ancell] died leaving Agnes a Brass pan, bedding and £10 [a large amount of money back then] [Ref: 11], Roberts father William died in 1602 leaving lands and a few animals to his grandchildren Robert, William, Elizabeth and Bennet and his mother [Elizabeth] died in 1610 leaving money to all her grandchildren [Ref: 1 & 2]

Robert and Agnes's wealth in the village was growing, in 1603 Robert purchased $1\frac{1}{2}$ acres of pasture and 6 acres of arable land plus Crabbes Cottage, Church End, Pirton from George Copcote [the same family who had been in a dispute with Agnes' brother]. Robert's residency is again documented in the Manor Court Rolls of 1610 "Property, Church End, has land named "Crabbes", Rent 6 shillings" and Elmtree Farm [Ref: 6 & 7]

In 1617 ownership of a house named Bury End was passed to Agnes by John Ansel, Agnes transferred her ownership to their son Bennet, the transcription states the transfer was in 1660 but Agnes died in 1618, I therefore believe she actually transferred the ownership prior to her death. [Ref: 12]

"1660 Manor of Pirton Doddingselles - Agnes Collison transferred ownership to Benedict Collison. Benedict is the son of Agnes Collison"

AGNES DIED IN 1618 AND WAS BURIED AT ST MARY'S CHURCH, PIRTON ON THE 25TH JANUARY 1618, [Ref: 3] LAST WILL AND TESTAMENT - NOT FOUND.

In 1628 Robert then aged about 65 is attributed to having the "dilapidated Crabbes Cottage" [consisting of one room] demolished and a new "brick" house was built in 1629,

House with 6 acres called crabs, Church End old house demolished and new one built, Church End and Robert Collison holds 1 property with 6 acres of land called Crabbes, rent 6 shillings [Ref: 7 & 8]

The new house consisted of 3 rooms on 2 floors, the central room downstairs being the main entrance hall, a meeting room and having stairs to the upper floor [The house was passed down through generations until 1738 and continues to be lived in.]

On the 22nd February 1629 Robert had his Last Will and Testament written in the presence of John Hammond, Luke Gaddeson and Robert Maeger; Robert signed his will, indicating he was educated. [Possibly taught in a room at the local church]. He named all his family in his will, his second son William had recently died and Robert ensured that provisions were in place for his widowed Daughter-in-law "Elizabeth" to be secure [providing she didn't remarry] and his Grandchildren would have a good start in life. [Ref: 13]

Robert's Inventory described his six roomed house with a hall, a room over the hall, a chamber over the hall, a parlour, kitchen and buttery; he also owned two barns. His farm consisted of 33 acres of barley, oats, wheat, peas, thatches, horse corn, hay and wood to the value £118 16 shillings and 8 pence.

Agricultural equipment - 4 carts, 4 pairs of wheels and 3 ploughs were valued at £18 10 shillings and his animals - 3 horses, 3 hogs and 3 geese were valued at £22. Robert's clothes were valued at £5 3 shillings and 4 pence and his Household goods valued at £11 6 shillings and 4 pence - a total value of £151 3 shillings and 8d [Todays value nearly £20,000] His Sword and Dagger were listed as valuables [Ref: 14]

At the time of Robert's death, his children all had their own cottages,

I. son - Robert had the leasehold of Crabbes Cottage and Elmtree Farm transferred to him,

II. late son - William, Elizabeth his widow and family living at unknown

III. son - Bennit lived at Bury End.

IV. daughter Elizabeth married William Bigge [also spelt Bygge] son of a local Yeoman William Bygge, they married in Willian, a neighbouring village on the 21st November 1611, they had their first child baptised in Pirton but subsequent children were baptised in Willian

Pirton Local History Group were able to reconstruct the house with its contents due to the detailed inventory carried out after Robert's death, which included his valuables - a sword and dagger! [A sign of the troubled times] [Ref: 7, 8, 13 & 14]

- Jone / Johane Sam [Spelt Jone, Joan & Johane] was also born in the village of Pirton, I thought she was Baptised on the 27th July 1600 and was the daughter of John Sam but a Will written by Thomas Sam states Joane was his daughter [Possible transcription error was Thomas her brother? FURTHER RESEARCH REQUIRED].
- The "Sam's / Same's" were a large family who had been in the village for centuries, they were named in the Court Rolls of the 14th Century and in 1500 a Thomas Samme was admitted to the Court Rolls "as owns of 3 howesynges, Hobbesyngs and Bakkesters"; they also owned / leased land and property in the village and rented Crabbe Cottage in 1553. On the 13th July 1629 at the Quarter Sessions a Robert Samme the village constable was removed from office as it was considered that he was unfit to serve as he lived with his father and was little more than a servant so Pirton had to elect another more suitable constable. [Ref: 3]

SUMMARY: Robert [2] was baptised on the 1st November 1586 and was the eldest son of Robert [1] and Agnes. At the age of 16 in 1602, Robert's Grandfather William, bequeathed him a great wether [a castrated male sheep] and a quarter of Barley. In 1603 his father purchased land and Crabbes cottage and in 1610 he was bequeathed money by his grandmother, his mother Agnes died in 1618.

The Manor Court Rolls record of 1628 record his father had Crabbes cottage demolished and a bigger house built in its place and in 1629 Robert was made executor of his fathers will with his cousin John [eldest son of his Uncle William]; his father died in 1632 and his properties and land was transferred to Robert and his wife*. [Ref 6 & 7]

• I have not found a record of marriage, issue or burial of a wife prior to his marriage in 1637

Possibly a widower without issue, Robert [2] was about 51 when he married Joan, [who was at least 37], they married on the 30th August 1637 and twelve months later they had a son whom, as per tradition - they named Robert [3]. I have not found evidence of other children. [Ref: 3]

Robert [2] and his family lived at Elmtree Farm and rented "Crabbes" to his nephew John and his wife Mary. The family's wealth continued to grow and Elmtree farm had been extended as in his lifetime it was described a 6 roomed house. In 1647 Jone, was bequeathed 13 acres of land by her father Thomas Sam [Ref: 6 & 7]



In 1645 Oliver Cromwell based his headquarters in the Sun Hotel [Image: Right] in Hitchin [not far away], many of his militia were stationed in and around Hitchin; unlike many local families of the time Roberts's family were prospering... There is evidence in previous and future generation that the family were involved in the brewing and selling of Beer, Mead or Ale, so was the family supplying Cromwell's militia with Ale?

By 1655 Robert was 69 years old and was putting his affairs in order by attending to his Last Will and Testament, he referred to himself as the "Elder of Pirton" and a Yeoman; his Will was brief and written on the 31st December 1655 leaving everything to his wife and son Robert [confirming that he had no other living children] [Ref: 17]



• This was the time of the Civil War, the local vicar Henry Dene became a Baptist and joined Cromwell's army and headed a mutiny against the King and his superior officers in 1649, later he was condemned to death but pardoned. [Ref: 16]

According to Robert's inventory ROBERT COLLISON DIED 14TH FEBRUARY 1657 [BURIAL NOT FOUND]

- There is a record "Robert Collison buried 5th September 1657" at St Mary's Church, Pirton, [Ref: 3]
- According to the inventory Robert died 14th February 1657 [Ref 17], I have therefore excluded September 5th to be Robert's [2] burial.
- Robert son of William [Robert's [2] nephew] was buried in 1659 [evidenced by LW&T plus burial records which state he was the son of William] [Ref: 28]
- I therefore believe the September burial to be that of his nephew "Robert son of Bennet Collison" [baptised 1635] as he is not mentioned in his father's LW&T of 1884 or any other documents. [Ref: 3]

Robert's Inventory describes his 6 roomed house with a hall, loft over the hall, parlour with 1 hearth, loft over the parlour, kitchen and a loft over the kitchen; his clothes were valued at £4 and household goods £18 3 shillings and 6 pence; his farm consisting of wheat, Barley, peas, oats, 70 sheep, 3 horses, 6 cows, 4 stores and chickens was valued at £127 9 shillings and 6 pence, his equipment consisting of ploughs, 5 harrows and 2 roules was valued at £12 5 shillings. Roberts's total estate was valued at £210 17 shillings and 6 pence [over £22,000 today] {Ref: 3] Prior to Roberts's death he transferred Elmtree Farm to his son Robert [3]

- 1659 Pirton Court Rolls the ownership of Crabbes Cottage was passed to his nephew "John Collison" [son of his brother William]
- John Collison died in 1659 so it would have been passed on to John's son also named John. [SEE JOHN [1] COLLISON]

St Mary's Parish records cite "Joane Collison wife of Robert Collison buried on the 17th August 1664, there is another entry for the 19th April 1671 again citing Joane wife of Robert Collison. I found an Inventory at HALS dated 1671 [Ref:31], which contains the will of Robert dated 31st December 1655, confirming his death on the 14th February 1657 and the Inventory dated 12th May 1671, less than a month after the second entry burial of "Joane wife of Robert Collison"; I therefore conclude that Joane Collison [maiden name Sam] died in 1671.

- As previously mentioned, in 1650 there were four Robert Collison's by 1659 his father and cousin [son of William] had passed away but whilst there is a record of baptism in 1635 for Robert Collison - son of Bennit, I believe he died in 1657, therefore by 1664 there was only 1 Robert Collison living in Pirton.
- Susan Hammond Evidenced from LW&T Robert Hammond & Eton College Archives. In 1672 Robert Hammond, a local land owner wrote his Will that said "and to my Daughter Susan Hamond the new wife of Robert Collison" [Ref: 18] and in 1673, Eton College record:- A "Robert Collison was the guardian of Richard Hammond" the son of a deceased local gentleman of the same name and they jointly leased lands off Eton College. [Ref: 5 & 19]
 - o I have found no record of marriage to Susan Hammond, issue or Burial in Pirton or the area.

 Susan was the daughter of Robert and Susana Hammond born 7th September 1642 in Pirton, she had a sister Elizabeth born on the 28th April 1645 and her brother was baptised on the 13th December 1655 in Pirton; their mother was buried on the 26th August 1672 and their father a few months later on the 30th December 1672, her brother Robert would have been 17 when his parents died, therefore Robert [3] Collison would have been his quardian until he was 21. [Ref: 3, 18 & 19]
- Ann Blows The only reference to "Ann" is in the Manor Court Rolls Transcription as " Ann Blows mother of Robert", I have no further information was Ann his mother or quardian after his mother died? [Ref: 6]
- Jane Again, I can find no record of a marriage locally to Jane but there is a record of a Robert Colson marriage to Jane Rogers in 1689, Stanton Long St Michael, Cambridgeshire. Robert names his wife as "Jane" in his Last Will and Testament with young children named Daniel and Jane born after 1690, they were considerably younger than his son Robert [4] who had children of his own at the time of his death.

SUMMARY: From the mid to late 1600's we had the English Civil War, Charles I beheaded in 1649, Anglo-Dutch War, Oliver Cromwell, Christmas cancelled, Richard Cromwell, Charles II crowned in 1660, the Plague, Typhoid, Cholera and the Great Fire of London of 1666, radical groups emerged like the "Seekers, Ranters, Diggers and Levellers" and the power of the church was reduced allowing other religions to emerge, Pirton being relatively close to London saw much of the "goings on" but few were involved.

Robert [3] was the son of Robert Collison and Joane Sam, baptised in Pirton on the 16th August 1638, he grew up on Elmtree Farm which had been in the family for generations, his father died when he was 18 leaving him and his mother the Farm to be officially in his name in 1658. Whilst his childhood was more comfortable than most, living through the Civil war with Cromwell's troops on the doorstep etc. I think it was a time to keep your head down for fear of being executed.

At this point evidence is chiefly obtained from Manor Court Rolls, Eton Archives and Wills and from this, however this period is confusing, I believe Robert married at least 3 times. Most marriages in this period were at the age of about 21, it was only the noble families which tended to marry younger and based on burial records I believe Robert married his first wife named Jone / Joane about 1659, she died in 1664 was buried at the Church of St Mary, Pirton. [Ref: 3 & 31], Between 1660 and 1673 Robert had a son, whom as per tradition was also named Robert [4], Baptism Record not found [Ref: 6, 20 & 33]: in 1671/2, the Last Will and Testament of Robert Hammond cites "his daughter Susan Hammond was recently married to Robert Collison" [3]. [Ref:18] [Parish record not found] and the Manor Court Rolls of 1698 "Ann Blowes" is named as the mother of his son Robert. Divorce was unusual with exception of the Nobility, so was his son "illegitimate"?

On Lady's Day 1672 [25th March] Robert [3] and Robert Hammond signed a leasehold to share "the Manor of Pirton and 2 woods named Oddingsells with exception of the great trees. From Lady Day for 21 years"

Rent £14 4shillings and 4 pennies plus 10 quarters, 5 bushels, 2 pecks of wheat, 14 quarters, 2 bushels of Malt or their monetary equivalent 20 good wether [castrated] sheep or 6 shillings and 8 pennies, 1 good boar or 33 shillings and 4 pennies

A counterpart of the lease stated Robert [3] Collison was the Guardian of Robert Hammond [Ref: 19]

The Hammond's and Collison's had known each other for many years, they had been witnesses at the writing of Wills, inventories, whilst the Hammond's featured amongst the wealthy of the village, there was obviously a degree of mutual respect for each other demonstrated by the marriage to his daughter Susan and Guardianship of his son.

Whilst Robert lived at Elmtree Farm he had the house extended, it was now a 10 roomed house with a Hall, chamber over the hall, a "Best" chamber, dairy, parlour, kitchen, dairy, Brew house and drink house and he kept bees; according to his inventory his house had 1 hearth yet he was subjected to Hearth Tax for 5 hearths in 1663 plus Rent. [Ref: 3 & 6]

I found no record Susan's death however I did find a possible marriage for his 3rd wife Jane... When Robert was about 51 he married Jane, [Jane Rogers in 1689], she was much younger than Robert and possibly younger than his son Robert, they had two children named Daniel and Jane both born after 1690 [Ref: 20].

In 1694 Robert's son [Robert 4] married Ann Marshal in a neighbouring village, they went to live in Hitchin and in 1698 Robert started to put his affairs in order, according to the Manor Court Rolls, he transferred Elmtree Farm to his son - Robert [4] and a year later his son, wife Ann and mother Ann Blows were entered into the Court Rolls and at the Quarter Sessions of 1699, Roberts Estate was valued at a rateable tax of £10 per year...

Robert [4] his son, died in 1710 in Hitchin [Ref: 21 & 33]. Robert [3] had his Last Will and Testament written in 1711 leaving lands and properties to his "Loving Wife Jane" to be shared with his children Daniel and Jane when they reached the age of 21 and in 1712, he wrote a Codicil [amendment]. He referred to his son Robert deceased of Hitchin and names his younger two grandchildren [he had at least five].

Robert's Inventory described his 10 roomed house with 1 hearth, household goods valued at £28 11 shillings, cash £53 plus 65 acres of land with crops of chaff, wheat, barley, peas, oats, thatches, dung, straw valued at £165; his 3 carts, 3 rowls, 6 harrows, 3 ploughs, 3 cart ladders, 2 ladders and 2 drag rakes were valued at £105. Robert's Horses, 2 cows, 2 hogs, hive of bees and poultry was valued at £18 3shillings and 6 pence; total value £279 8 shillings and 6 pence [about £30,000 today]

- Land and properties possibly relinquished due to her re-marriage; I surmise that his son Robert's family took over all their land and lease agreements.

SUMMARY: England was unsettled post Civil War, taxes were high and disease rife including the Plague, Christmas was even cancelled for a few years, New religions were emerging and the power of the church gone. Life in England had changed. I have found evidence of "Crowdfunding" in the back of Parish record books, where each week the Parish Priest would ask for donations for one cause or another [including the Great Fire of London]. however as we have seen, vital parish records are missing and during this period I have been reliant on Wills and Manor Court Rolls

The Collison's had moved from Pirton to Hitchin but kept the leasehold of lands and properties in Pirton, Ippolits and Bedfordshire. The area was known for its Malting and Brewing, relevent to the Collison's as we have seen evidence in the Last Will and Testament of William Collynason [died 1602] Roberts' Great Great Grandfather having a Malt House and growing crops used for making ale / mead, plus the inventory of his father Robert [3] [1638 - 1713] owning a "Brew House and Drink house" and in 1714 there is an apprentice record for his son that states Robert was a "Malster" [a person dealing in the selling of alcohol or the cereals required for the brewing of beer etc.].

ROBERT COLLISON MARRIED ANN MARSHALL 30TH OCTOBER 1694 AT IPPOLLITTS, HERTFORDSHIRE RECORD TRANSCRIPTION: IPPOLLITTS, , REF: BIRTH, MARRIAGE, DEATH & PARISH RECORDS, Robert Collison & Ann Marshal were married Tuesday ye 30 of October 1694

In 1698 the Manor Court rolls record the transfer of Elmtree Farm from Robert [3] to his son and in 1699 the court also admits Ann his wife plus Ann Blows Roberts mother. Roberts' occupation was a Maltster [Evidence: baptism of children and apprentice records of son - Robert [5]

Robert and Ann married in the village of Ippollitts in 1694, they lived and attended chuch in Hitchin where they had four children baptised, Susannah 1698, Ann, Elizabeth and John who were all baptised together in Hitchin in 1709], they had other children, one of whom was named Robert [5], who was their eldest son but I have been unable to find his baptism [Evidenced by Apprentice records and Manor Court Rolls].

In 1698 Robert's [3] father transferred the ownership of Elmtree Farm to Robert [4] and Ann his wife and in 1699 Robert, his wife Ann and Ann Blows* his mother were admitted to the Court Rolls...

FIND MY PAST REFERENCES

Summary: Robert [5] was born in 1701 in Hitchin, his father died when he was about nine years old and his grandfather died before June 1713. I am confident the record of baptism and apprenticeship for "Robert Collinson" is the same person, his father was a "Maltster"; the name Collison was spelt many ways over the generations [spellings of names not formalised until the registration of births, though there were still variations during the 19th and early 20th century].

If Robert completed his apprenticeship, he would have done so by 1721 but in 1721 Robert was recorded as a "Mealman" a dealer of grain, corn, wheat and flour, all the main ingredients for the dietary requirements of the day. In all the Baptism records of his children, Robert was a "Last maker"; by 1752 Robert is recorded as a Yeoman - a farmer / owner of properties and lands and finally at his burial Robert is described as a Gentleman Farmer... He was never referred to as a "Staymaker", but all records are confirmed by later evidence found in Wills and Monor Court Roll documentation.

Last Maker: maker of a mechanical form to make a foot which was used by shoe makers / cordwainers to make or repair shoes. A last maker was a highly skilled occupation [I wonder if he owned the business]

ROBERT COLLISON MARRIED DOROTHY UNDERWOOD 30TH APRIL 1721 AT THE CHURCH OF ST MARY AT GRAVELY CUM CHISFIELD, HERTFORDSHIRE

In the Pirton Manor Court Rolls for Elmtree Farm in 1720 Dorothy, wife of Robert is named and there is also documentation in 1722 of Robert Collison of Hitchin owning the property and 30 acres but rented to Edward Lacy. They also owned property in Weston, Hertfordshire

Robert and Dorothy had at least 9 children 5 of whom died in infancy, the first three were baptised in Hitchin but between 1726 and 1729 the family moved to Roberts's ancestral home of Pirton and is named in the Pirton Manor Court rolls of 1735 as the occupier of Elmtree Cottage. As previously mentioned Robert's occupation was confusing, early apprentice records suggest he went to London as an apprentice to a Draper [to a Staymaker], baptism records of his older children suggest he was in the shoe trade and later records state he was a Mealman and a Farmer. The years around 1732 document Robert as being an "Overseer" in the village, making payments from the village purse to the poor, workers employed by the village etc. The family were moving away from their traditional family home of Pirton.

Early in October of 1743, Dorothy wife of Robert died and was buried on the 9th October 1743 at Ippolitts; she would have been about 40 years old, she left a Last Will and Testament which was the cause of a legal dispute between her children and a local land owner in Weston [Further research required].

Robert and his new family settled down to the life of a gentleman farmer in Gosmore, Ippollitts. In 1753 he paid Land Tax of £1 10 shillings [Ref: 42] and in 1760 he passed the ownership of Elmtree Farm to his eldest son John who was a Coal Merchant in Hitchin.

On the 8th July 1776 Robert began to put his affairs in order and wrote his Last Will and Testament

Williams Inventory included a long table with 6 joined stools, 10 Pewter platters with other small pewter, 1 chair, a bedstead and bedding plus 1 feather bed with bedding, two chests, a presse, cofer, his wearing apparel, tubs and barrels; its value amounted to £12.1 shilling and 2 pennies.

In 1632 Williams children Robert, Elizabeth and Mary were bequeathed Thirty Pounds each by their Grandfather Robert Collison [1] to be received 3 years after his death and stated that they were to be bought up decently and maintained until they were over 16. Elizabeth their mother was left an annual income of £4, providing she didn't remarry. William's eldest surviving son John was made joint executor of his uncle's estate.

Summary: John was the eldest son of William [2] and Elizabeth was born between 1611 and 1620 [baptism not found]. In 1629 he was recorded in the Last Will and Testament of his uncle Robert Collison [2] and named as an Executor of the Will along with his cousin - also named Robert [2]. His grandfather died in 1632 and he went to live at Crabbes Cottage as he is named in the Manor Court Rolls where he was recorded paying tax to relieve the British Army in Ireland [His cousin Robert Collison [2] retained ownership].

John's mother Elizabeth died in 1641 and he married Mary Bigge in 1645 in the neighbouring village of Ippollitts [The Pirton vicar had become a Baptist and fled the village]. Between 1646 and 1658 they had three children John, Elizabeth and Mary.

SUMMARY: The Pirton Manor Court Rolls for Holly Cottage, Hambridge Way, record that between 1640 and 1659 Robert took over ownership from a Katherine Carter. There are no records of marriage or children for Robert and his will only names siblings and their children.

Robert's older brother John died and was buried on the 10th March 1659 and made Robert one of the Executors of his will to ensure his son and daughters were well looked after. Robert soon found that land bequeathed to John's son was infact "Leashold" and therefore could not be part of the inheritance [Ref: 26]. A few months later Robert himself became ill, he

transferred ownership of Holly's Cottage to his nephew John and made his will on the 26th June when he referred to himself as "Robert Collison the elder, Yeoman" [both his uncle Robert and cousin died in 1657], he died days later, buried on the 29th June 1659.

See Collison v. Collison 1668 - Summary Mary Collison [5th Generation]

HOWEVER: John Collison, Robert's nephew retained ownership of Holly's cottage for a few years until "John Sheppard" was documented as owner in 1675. The Sheppard family had ownership until 1684 when "Thomas Burrowes" takes over the cottage for "Dorothy How" [widow] of St Gregory's London. The Manor Court Rolls state that a William Hancombe was the tenant of Holly's cottage but was evicted as Dorothy wished to live there taking over the house plus 20 acres of land, 2 acres of meadow and 5 acres of pasture. In 1697 the Manor Court Rolls document that Dorothy passed on ownership of Holly's Cottage plus land to Elizabeth Degg on the basis that Robert Collison was Elizabeth's father. [Dorothy also had a son named Samuel Howe]

As documented above Holly's cottage was passed on to John the nephew of Robert in 1659, in 1710, Roberts nephew John made his daughter Elizabeth Fordham [married to Ralph Fordham in 1703] the owner of the cottage and in 1735 Elizabeth Fordham [daughter of John Collison] transferred ownership to Edward Wilson - the court rolls also record that her father John lived in the house prior to his death But in 1738 the Manor Court Rolls say that Dorothy How transferred ownership to a Mrs Ray - heir of Dorothy Howe and Dame Elizabeth Sanderson [Dorothy's daughter] widow...... 50: Questions...

SUMMARY: John was born at Ippollits or Pirton between 1646 and 1655 and baptised on the 26th January 1655 at Pirton and was the son of **John Collison and Mary Bigge**; he had two sisters Elizabeth and Mary. His mother died before 1658 and his father died in 1659 when John was still a minor, his Uncle Robert and Grandfather Christopher Bigge were guardians of John and his sisters. His uncle Robert died later in 1659 leaving them under the guardianship of his Grandfathers brother Bennet Collison and their Granfather Christopher Bigge who lived at St Ippolitts [a neighbouring village], Christopher died in Ippollitts in 1661.

In 1659 John was bequeathed 6 acres of free land to have when he was 16 years old and Robert Collison transferred ownership of Crabbes Cottage to John, However he did not receive the land bequeathed to him as the land was "Leasehold" and did not belong to his father. In 1677 John married Elizabeth Ansell at Pirton on the 26th October, Elizabeth was possibly a descendant of one of his Great Grandmothers brothers [Agnes Auncell]. John and Elizabeth had a daughter Elizabeth baptised 16th September 1680, I have found no evidence of other children baptised or buried.

1699 Quarter Sessions: John's estate was valued and ordered to pay £10 a year tax

In 1703 their daughter Elizabeth married Ralph Fordham on the 23rd December and in 1704 John Collison transferred ownership of <u>Crabbes</u> Cottage to her. John wrote his Last Will and Testament in 1710 leaving everything to his wife and daughter and was buried in Pirton on the 5th October 1710, his wife died in 1718 and was also buried in Pirton.

Summary: Mary was born about 1653 [Ref: 26], her mother died at or shortly after her birth and her father died when she was about 6 years old in 1659. I have not found any record of baptism but she is named in the Last and Testaments of her father John [c. 1620 - 1659] her Uncle Robert and Christopher Bigge her grandfather were made executors of her fathers Will, [it is unclear if they were her guardians],

Her father John [c. 1615 - 1659] had made provision for Mary and her siblings [her older brother John and Elizabeth], her brother was to receive 6 acres of land but the land was found to be leasehold, therefore the land was not inherited. Elizabeth and Mary were also bequeathed One Hundred Pounds to be received on their Sixteenth birthday. Monies from the sale of Bonds and properties were used to pay for John, Elizabeth and Mary's education and upbringing until they were of age [sixteen years old].

In 1668 Mary wrote a letter to the Rt Honourable Orlando Bridgman, Knight and Keeper of the Great Seal of England; [Ref: 26]. Mary felt cheated of their inheritance and put the responsibility with Bennet Collison and Christopher Bigge [A George Collison of Bedfordshire is also named, it is unclear how he is related]. [Ref: 26]

In brief: Mary accused her Grandfather's brother Bennet Collison of mishandling her father's estate and withholding one hundred pounds and household stuffs bequeathed to Elizabeth and Mary in his will of 1659. It was dealt with by the "Prerogative Court of Canterbury" and the documents are held by the National Archives. Mary was about 16 years of age when she wrote the letter and clearly had a good education, a subsequent enquiry took place.

The documentation held by the National Archives include: Mary's initial letter, accounts and correspondence relating to the outcome. I am unable to transcribe but from my knowledge of her Father and Uncles Last Will and Testament I understand that:-

One of the executors of her father's will [her Uncle Robert] discovered bequeathed land left to her brother John was "Leasehold" therefore could not be included in the will, her Uncle died just a few months after her father and he passed on the responsibility to Bennet Collison [brother of her Grandfather William]; The other executor Christopher Bigg [Father of her mother] died two years later in 1661, he passed on his responsibilities to his son also named Christopher - the findings of the inquiry detailed costings for the children's upbringing and education but also stated "Christopher Bigge had little understanding of the bequests made".

I have not found any information relating to Mary or her sister Elizabeth in the Manor Court Rolls of Pirton therefore I assume the legacy from her father was accounted for and Mary lost her appeal.

Mary married William Russell in 1676 in Enfield, Middlesex, London; they had four children. Elizabeth her sister also lived in Enfield, she died in 1679. In 1710 her brother John bequeathed five pounds to each of her children. I have been unable to find a death for Mary.

SUMMARY: Bennet [also spelt Bennitt and Benit] was the youngest son of Robert and Agnes born about 1601 and baptised at the Church of St Mary, Pirton. In 1602 his Grandfather William died shortly after his birth but Bennit was included in his Last Will and Testament where he was bequeathed $3\frac{1}{2}$ acres of freeland, $\frac{1}{2}$ acre at Priors Hill, $\frac{1}{2}$ acre at Egles Mare, a Reed faced ewe and her lamb and 2 quarters of Barley to be received when he reached the age of 21. Bennet's grandmother Elizabeth, left him £3 to be received 3 months after her death which was in 1610. Bennit lived with his parents and siblings at Elmtree Farm, his mother died in 1618 but prior to her death the ownership of Bury End, was transferred to Bennet. In 1626 Bennet married Joan Sex [another family with a long history in the village] and in 1627 they had a daughter Joan, 1629, a son Bennet and in 1635, son named Robert, all names in keeping with tradition of the times. I have found no further reference to "Joan or Robert" in any of Bennet's or Pirton's documentation, I therefore assume they died [Robert possibly died in 1657].

Bennet had been well provided for early in life, he was a farmer, be it on a small scale and held respect within the village; his Brother William died in 1629 and his father Robert died in 1632 and left him 20 shillings plus 20 shillings each for his son Bennet and daughter Joane.

Prior to 1663 Bennet also acquired a property now known as 16 Great Green which was rented out to a man named Parkinson and subject to Hearth Tax [Bennet was taxed on 6 hearths but I think that was for all the properties he owned rather than just one] The house at Green appears to be of early 17th Century construction and a similar plan to Crabbes cottage.

In 1668 Bennet's wife Joane died and was buried at the Church of St Mary, Pirton - she would have been 71 years old.

1668 Bennet was accused by Mary Collison [Grandaughter of his brother William] of withholding property bequeathed to her in her fathers will. The case was conducted by the Prerogative Court of Canterbury, it appears no charges were filed against Bennet.

1770 his son married Elizabeth Stringer from Bedfordshire, they had two daughters Joan and Elizabeth but his son Bennet died in 1674 and shortly after his wife with 2 young daughters remarried John Davis

During Bennet's life his name appeared in many inventories in the village and around 1685 Bennet started putting his own affairs in order, ownership of 16 Great Green was passed to Joan Constable and Elizabeth Burrows [his Granddaughters, daughters of Bennet], Bury End was transferred to John Davis [the 2nd husband of Elizabeth his daughter in law]. Death duties were high and by transferring ownership of property and land was a way to avoid some of the cost. There appears to be no date on Bennet's Last Will and Testament but probate was been filed as 1685. I have found no burial for Bennet Collison

Summary

It is unclear if Bennet fought in the Civil War but it does appear he was away from the village at the time in question. Bennet married Elizabeth Stringer in Stofold, Bedfordshire in 1670 and came home to Pirton where they had a daughter who they named after his mother Joane, in 1671 and a daughter Elizabeth baptised in 1673 a year later Bennet died and was buried in Pirton on the 3rd October 1674; I have not been able to find an inventory or Last Will and Testament.

Following the death of Bennet his wife Elizabeth married John Davis with whom she had a son who they also named John. Elizabeth died after the writing of Bennet's LW&T but before 1685.



ELMTREE FARM HAMBRIDGE WAY, PIRTON

A survey of the house states the oldest part of the house is very old but no date is given, it was a two storey construction with a ladder to access the upstairs. It had a large fireplace and windows with sliding shutters. Robert (1) had the property extended as described in phase 2 of the Architectural detail. Robert's (2) Inventory describes a 6 roomed house which suggests the property had moved into phase 3 of its extension. Robert (3) [1638 - 1713] paid hearth tax for 5 hearths in 1663 plus manor rental of 12 shillings. Evidence from his inventory record a 10 roomed house indicating Elmtree Farm been extended again and he paid hearth tax for 5 fireplaces suggest phases 4, 5, 6 and 7 occurred during his ownership, however the architectural survey states the fireplaces and extensions were added in the 18th Century - one hundred years later. John Collison sold Elmtree Farm in 1764 to a John Midwinter Surgeon of Hitchin.

In the early Manor Court Rolls of 1373 there are references to a Luke and John Crabbe, who possibly originally owned the land of which "Crabbes cottage got its name. 1586 William Collyngson [1535 - 1602] and his wife were documented living at Crabbes cottage Elizabeth died in 1610; according to Elizabeth's inventory, the property consisted of one room. In 1628 Robert had the old cottage demolished and a brick 6 roomed property built in its place. Once again the property is well researched, as per Elmtree Farm, the original part of the house remains but it has been extended over the years.

SUMMARY

Elmtree Farm was owned / rented by William Collison [c. 1535 - 1602] prior to 1584, at some point over the next few generations it appears to have been purchased by the family and during the mid 1600's extended [an additional 8 rooms added -. The farm remained in the family until 1764. Evidence: Manor Court Rolls, Inventories & Building Survey

Crabbes Cottage was rented by William Collison [c. 1535 - 1602] and his wife [Elizabeth c. 1535 - 1610] from about 1586 to 1610 but purchased by his son Robert Collison [c1564 - 1632] in 1603 who is attributed for the re-building of the cottage in 1628, the cottage remained in the family until 1738. Evidence: Manor Court Rolls, Inventories & Building Survey

16 Great Green looks to be of a similar construction to Crabbes Cottage and is first mentioned in the Hearth tax of 1663 in the ownership of Bennet Collison [1600 - 1684] and the building survey dates the property to the 17th Century, did the Collison's have this house built too? It remained in the family until about 1705. Evidence: Manor Court Rolls, Inventories & Building Survey

Holly Cottage appears to have been purchased by Robert Collison [2] [1586 - 1657] possibly due to its close proximity to Elmtree Farm, it remained in the family until 1739

Bury End was previously owned by the Ancell family and passed onto Agnes Collison [1564 - 1618] who bequeathed it to her youngest son Bennet [no building survey available to date the building] and it remained in the family until 1707

The Collison's certainly made their mark in Pirton and despite some Baptism, Marriage and Burial records being missing, the family has been brought together using Manor Court Rolls, Last Will and Testaments, records held by HALS and the National Archives confirming their ancestry and family ties; It has been a fascinating journey through time but a SPECIAL THANKS must go to the hard and dedicated work by the The Pirton Local History Group and help and assistance of Helen Hofton without whom this research would not have been possible. It is unusual to get such an insight into our ancestors lives and to know the actual houses they built and lived in is an absolute bonus especially our connection to Elmtree Farm and "Crabbes Cottage" [2 Crabtree Lane]
